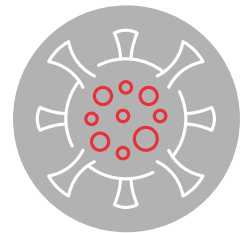
1) COVID-19 regulations BAHRAIN in general

1.1. Please check the website of the Bahrain Airport for latest detailed information about all travel requirements and restrictions for entering the country.

1.2. According to the entry requirements of Bahrain, people entering the country have to be fully vaccinated or need to go in a 10 days quarantine.

FOR DRIVERS ONLY (not applicable for entrants, mechanics or other supporters or companions): If you can't be fully vaccinated for juridical or medical reasons (eg. age limit in your country...), we need an official certificate confirming that the vaccination is not possible as well as following details: first name, surname, passport-no, date of birth, email address and postal address. Please send all the details to marketingrotax@brp.com with the subject: **RMCGF21 - Vaccination**

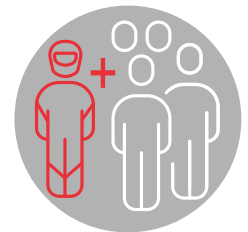


2) LIMITED ACCESS TO THE EVENT

In regards to the Covid-19 regulations, we have to limit the access to the event and number of participants. This means in detail:

2.1. We only allow 1 driver + 4 companions (includes entrant, mechanic and 2 supporters)

2.2. Further information regarding organisational procedures for the event coordination will be announced prior to the event.



3) CUSTOMS CLEARANCE/TRAVEL INSTRUCTIONS

3.1. It is mandatory for all persons to register prior to the travel.

We will provide you the link for the registration just in time before the event.

Not registered persons have to expect that there will occur problems with the entry at the airport.

3.2. There are strict import regulations in Bahrain for electronical and technical equipment (eg cameras, radios, drones ... and many more) as well as other goods. Details for the Customs Clearance are available on the following website:

4) HOTEL INFORMATION

Directly contact the Bahrain International Circuit (BIC) for hotel reservations, rental car bookings or for booking touristic activities as the BIC has cooperations with local companies and can support you. A list of hotel recommendations is enclosed to this infoletter.

4.1. For hotel reservation please send your data (name, rooms needed, date of arrival, date of departure) with the name of your preferred hotel from the list with the note „Rotax Grand Final“ to **Marita Liwanag (m.liwanag@bic.com.bh)** and she will support you with the bookings.

4.2. Same procedure as stated in 4.1. is effective for rental car bookings
